

TERMS AND CONDITIONS FOR INTERNATIONAL DANCE WORKSHOPS
UNITED SESSION DANCE FESTIVAL 2025

§1. General Information

1. The Organizer of the event is Centrum Kultury "Browar B.", ul. Łęgska 28, 87-800 Włocławek, Poland.
2. The Producer of the event is Kaczorex Michał Kaczorowski, ul. Wieniecka 38/15, 87-800 Włocławek, Poland, NIP 8883063462.
3. Date: July 1-4, 2025.
4. Venue: Park na Sładowie, ul. Szpitalna 33, 87-810 Włocławek, Poland.

§2. Participation Conditions

1. Only individuals who submit the registration form in the manner specified by the Producer and pay the appropriate fee in accordance with the price list available at www.united-session.com are eligible to participate in the workshops.
2. There are no age restrictions for participation. Participants under the age of 16 must have a consent form signed by a parent or legal guardian.

§3. Registration and Participant Limits

1. The number of participants is limited. Submitting the registration form and receiving an automatic email confirmation does not guarantee participation in the United Session Dance Festival workshops. Participation is confirmed only upon receipt of the registration form and full payment by the Producer. In the case of high demand, participation is determined by the order in which payments are received. Notification that registration has closed may be delayed.
2. The Producer reserves the right to close registration once the maximum number of participants has been reached. In such cases, those who have already paid may either transfer their payment to other styles within the United Session Dance Festival or request a refund.
3. The Producer reserves the right to cancel all or part of the workshops if the number of participants is insufficient to cover organizational costs. In such cases, registered individuals are entitled to a refund of payments made to the Producer for this purpose.

§4. Payments and Invoices

1. Payments must be made solely through the payment system, a link to which is available at www.united-session.com under the “Workshops” tab.
2. Participants may withdraw from the agreement within 14 days of purchase, unless the event takes place within less than 14 days of purchase. If cancellation occurs in writing no later than 14 days before the event, the participant is entitled to a refund, minus costs incurred by the Producer in organizing the United Session Dance Festival. The amount of the deduction will vary depending on the specific case. The Producer informs that historically, average deductions may constitute most or all of the paid amount.
3. Individuals who have not paid will not be permitted to participate in or observe the classes.
4. The workshop price covers participation in classes only. All other costs, including accommodation, meals, travel, and insurance, are the responsibility of the participant.
5. Invoices will be issued upon request. Interested participants should send invoice details to office@united-session.com.

§5. Safety and Liability

1. The Producer is not liable for accidents that may occur during the United Session Dance Festival. Participants are advised to have valid medical certificates and personal accident insurance. Participants are responsible for adjusting the intensity of exercises to their physical condition. Any alarming symptoms should be reported immediately to the Producer or designated staff.
2. The Producer is not responsible for lost or damaged personal belongings or for damages caused by participants during the workshops.

§6. Workshop Organization and Conduct

1. The Producer reserves the right to modify the workshop schedule.
2. Workshops will be held on the dates and at the location specified by the Producer. Any changes will be announced via the website www.united-session.com and official promotional channels no later than one day before the start of the workshops.
3. Recording or otherwise capturing dance classes is strictly prohibited without prior written consent from the Producer.

§7. Privacy Policy

1. Submitting an application to participate in the workshops constitutes acknowledgment and acceptance of these Terms and Conditions. The data controller is Kaczorex Michał Kaczorowski, 87-800 Włocławek, Poland, NIP 8883063462. The contact information for the Data Protection Officer is the same as that of the Data Controller. Personal data will be processed for marketing purposes and in accordance with the consents provided to the Data Controller. The legal basis for data processing is the consent of the data subject. Data will be processed until the purpose for which it was collected ceases or the data subject objects to further processing, whichever comes first. Each person has the right to request access to, rectification, deletion, or restriction of processing of their personal data, as well as the right to data portability and objection. Consent may be withdrawn at any time, without affecting the legality of prior processing. Complaints may be filed with the supervisory authority (after May 25, 2018: the President of the Personal Data Protection Office). Rights and consent withdrawals may be exercised using the contact details of the Data Controller or Data Protection Officer provided above. Personal data processing includes profiling for the purpose of tailoring commercial offers and potentially sending marketing communications. Objections to profiling and other rights may be exercised using the same contact details.
2. Participants consent to the use of their image for the promotion of the United Session Dance Festival.

§8. Final Provisions

1. Registering for selected workshops in the form linked at www.united-session.com constitutes acknowledgment and acceptance of these Terms and Conditions.
2. All matters not covered in the Terms and Conditions will be resolved individually with the Producer.
